	(2) The interview will be conducted in Cantonese, English and Putonghua.

## Points to note

- 1. Each student may apply to NOT MORE THAN TWO participating secondary schools listed in the Handbook for Application for Secondary One Discretionary Places, otherwise his/her chance of acquiring a DP will be forfeited.
- 2. Once the application form is submitted, it cannot be retrieved or cancelled.
- 3. All information provided will be solely used for the processing of the application.
- 4. Recommendation letters from the primary school are not required.
- 5. Our school will only interview the shortlisted applicants, the selection criteria are as follows:
  - (1) Position in EDB's 'DP Rank Order List' (50%)
  - (2) Academic results & conduct (25%)
  - (3) Extra-curricular activities or services (25%)
- 6. The school will notify the applicants by mail about the arrangements of the interview in late February.
- 7. Parents of successful applicants will be notified by letter and phone on 31 March 2026.

  These notification arrangements are not applicable to reserve and unsuccessful applicants.
- 8. Personal Data Collection Statement: All information provided will only be used for admission related purposes. Upon completion of the admission procedure, the information will be destroyed.
